Executive Director's Report - Elijah

Caswell is working from home and official date of retirement July 1, 2015. Office admin team Gwen Mullen, Erik Sunday, Vesna and Dan Hall

Roseboro has met with the CAO and CEO and will be peep at the Board Meeting on June 30th

Fundraiser – Date has been moved to October 22nd for additional planning. Board is responsible for a table. We are asking staff and teachers to purchase 2 tickets at 120-160 tickets.

Development efforts – submitted 3 proposals last week. We are working on a \$400,000 grant for 21st Century Learning Center. Scholars in Service. Scholars in Service will run 3 days a week and Saturday for community service. Students will do community service by going into the hospitals doing presentations to the sick and shut in. This is the service piece in Scholars in Service. We are also thinking about offering kids a stipend for kids.
